Narrative Information

On 04/01/19 at 2230 hrs, I was dispatched to ⁷¹⁰⁰ ~~BLK~~ Greenbank Rd, 21220, in reference to a family verbal disturbance.

I met with Complainant Christopher Bevins in the parking lot of the Dunkin Donuts located at 190 Carroll Island Rd. Upon speaking with Complainant C. Bevins, he advised that he and his parents, Interviewees Cathy and Richard Bevins got into a verbal argument about him moving out of the location. Complainant C. Bevins advised that during the argument, he grabbed some personal belongings and left the location in order to avoid further problems. Complainant C. Bevins further advised that no physical altercation took place.

I responded to the above address and spoke with Interviewees Cathy and Richard Bevins. They both advised that everything was fine and confirmed that no physical altercation occurred.
